## Boards, Commissions, and Like Entities Annual Report to the Legislature as of June 30, 2018

### Summary

The purpose of this report is to summarize information provided to the Division of Administration (Division) by boards, commissions, and like entities (Boards). Louisiana Revised Statute (R.S.) 24:513.2(E) requires the Legislative Auditor to submit annually to the Legislature a report containing summary financial information and personnel data on (1) Boards created by law or executive order that are made part of, or are placed in, the executive branch of state government and (2) local Boards that are specifically created by law. The statute provides for the Legislative Auditor to report findings and recommendations resulting from any analysis of the information. Our findings and recommendations are categorized as follows:

- **Boards & Commissions Website** - The Boards & Commissions website is at <https://wwwcfprd.doa.louisiana.gov/boardsandcommissions/selectBoard.cfm>. The accuracy of the information available is solely dependent upon the timeliness and accuracy of the Boards' data entry.
- **Trends** - This report identifies 477 Boards as of June 30, 2018, which is a net increase of 13 from the previous year.
- **Boards Providing No Response** - We identified three Boards that did not respond to our request for personnel data and financial information. The Division sent notices of noncompliance to the respective legislative committees as required by R.S. 49:1301. Two of the three Boards also failed to respond to our request in the prior year. We recommend that the Legislature take actions to require these Boards to comply with the law.
- **Inactive Boards** - We identified 14 inactive Boards that were not fulfilling their established functions. We recommend that the Legislature consider abolishing these Boards. Each of these Boards was also identified as inactive in the prior year.
- **Board Per Diems, Salaries, and Travel Expenses** - For fiscal year 2018, Boards budgeted approximately \$1.3 million for per diems, \$1.7 million for salaries, and \$2.1 million for travel expenses.

## Boards & Commissions Website

R.S. 49:1301 requires the Commissioner of Administration to establish and maintain a website containing information on Boards: <http://www.cfprd.doa.louisiana.gov/boardsandcommissions>.

We worked with the Division to add database entry fields to capture the required level of detail for board members' per diem, salaries, and travel expenses beginning with the fiscal year 2017 reporting period. Board members' per diems, salaries, and travel expenses reflected in the database for reporting periods prior to fiscal year 2017 should not be used without first confirming the information directly with the respective Board.

The accuracy of the information available on this website is solely dependent upon the timeliness and accuracy of each Board's data entry. As a result, anyone attempting to access information about current budgets or expenses for a specific Board may instead retrieve information that is outdated or inaccurate.

We recommend that the Division continue to work with our office regarding the form and content of the database fields to ensure information entered is properly maintained. We will also meet with the Division periodically to monitor updates and improvements to the website database.

## Trends

This report identifies 477 Boards as of June 30, 2018 (see Appendix B), which is a net increase of 13 from the previous year. This net figure reflects an increase of 20 and a decrease of seven Boards during the current year. Act 661 of the 2018 Regular Legislative Session abolished seven of the nonresponsive or inactive Boards identified in the prior-year report. The total number of Boards reported as of June 30, 2018, includes 15 Boards created during the 2018 Regular Legislative Session.

As noted below, the total number of Boards has fluctuated between 458 and 477 boards over the past five years.

## Boards Providing No Response

R.S. 24:513.2(F) directs all agencies, boards, commissions, and departments of the state and its political subdivisions to furnish information and reports as requested by the Legislative Auditor to fulfill his responsibilities. All Boards were requested to provide contact information, membership information, and statutory or legal authority relative to the entity.

R.S. 39:1335 and 1336 require licensing agencies to provide summary and detailed information pertaining to actual and budgeted revenues by source, expenditures by category, and fund balances; performance indicators; and certain general information pertaining to the Board and its authority and functions.

All other Boards were requested to provide similar information, except that the financial and budget information was requested in summary form only, and information pertaining to performance indicators was not requested.

As of June 30, 2018, we identified the following three Boards that did not respond to our request for personnel data and financial information. Two of these Boards also failed to respond to our request in the prior year.

A joint letter from the Legislative Auditor and the Commissioner of Administration requesting information was mailed to the Boards identified in our report (other than those Boards that were created by legislation or executive order during the 2018 Legislative Regular Session). Numerous attempts to contact those Boards that did not submit the requested information were made by the Division's staff, with no response from these entities.

In accordance with R.S. 49:1301, the Division sent notices of noncompliance to each Board that failed to respond to its requests. In addition, notices of each entity's failure to respond were sent to the state departments of which the entity is a part, the Senate Committee on Senate and Governmental Affairs, the House Committee on House and Governmental Affairs, and the oversight committees for each Board. The Legislature may wish to consider taking some action against Boards that fail to comply with the reporting requirements in state law.

## Inactive Boards

The following 14 Boards were never fully organized; were disbanded with no plans to reorganize; were inactive; or had no funding prospects to undertake the functions for which they were established. All of these Boards were also inactive during the prior year. Because these entities are not fulfilling their established functions, the Legislature should consider abolishing them.

## Board Per Diems, Salaries, and Travel Expenses

Of the 477 Boards listed in Appendix B, 134 reported budgeted payments for Board member per diem, salaries, and/or travel for fiscal year 2018, as listed in Exhibit 1 below. Of the remaining 343, three failed to respond to the request for information and the remaining 340 indicated no payments were budgeted for Board member per diem, salaries, or travel for fiscal year 2018. Boards will submit actual expenses from fiscal year 2018 during the fiscal year 2019 reporting period which began on October 1, 2018. Boards have until May 1, 2019, to enter fiscal year 2019 budgets along with fiscal year 2018 actual expenses in the database.


