INDEPENDENT ACCOUNTANTS' COMPILATION REPORT

Management is responsible for the accompanying financial statements of the governmental activities of Park Forest Crime Prevention and Improvement District, a political subdivision of the state of Louisiana, as of and for the year ended December 31, 2022, which collectively comprise the District's basic financial statements as listed in the table of contents, in accordance with accounting principles generally accepted in the United States of America. We have performed a compilation engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the financial statements nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by management. Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on these financial statements.

Management has elected to omit substantially all the disclosures required by accounting principles generally accepted in the United States of America. If the omitted disclosures were included in the financial statements, they might influence the users' conclusions about the District's financial position and changes in fund balance. Accordingly, these financial statements are not designed for those who are not informed about such matters.

The supplementary schedule of compensation, benefits and other payments to agency head or chief executive officer is presented for purposes of additional analysis and is not a required part of the basic financial statements. The supplementary information has been compiled from information that is the representation of management. We have not audited or reviewed the supplementary information and, accordingly, do not express an opinion or provide any assurance on such supplementary information.

As provided for under requirements of Louisiana Revised Statute 24:513, Park Forest Crime Prevention and Improvement District has not adopted the provisions of Governmental Accounting Standards Board Statement No. 34 for the year ended December 31, 2022. The effects of this departure from accounting principles generally accepted in the United States of America have not been determined.

The financial statements of Park Forest Crime Prevention and Improvement District were not timely filed with the Louisiana Legislative Auditor. LSA-RS 24:513(5)(a) requires the engagement to be completed within six months of the close of the entity's fiscal year.
