Summary

The purpose of this report is to summarize information provided to the Division of Administration (Division) by boards, commissions, and like entities (Boards). Louisiana Revised Statute (R.S.) 24:513.2(E) requires the Legislative Auditor to submit annually to the Legislature a report containing summary financial information and personnel data on Boards included in the database. The statute provides for the Legislative Auditor to report findings and recommendations resulting from any analysis of the information. Our findings and recommendations are categorized as follows:

- **Boards & Commissions Website** The Boards & Commissions website is located at <u>https://wwwcfprd.doa.louisiana.gov/boardsand</u> <u>commissions/home.cfm</u>. The accuracy of the information available is solely dependent upon the timeliness and accuracy of the Boards' data entry.
- **Number of Boards Reported** As of June 30, 2023, the website contains information on 483 Boards, which is a net increase of five from the previous year.
- **Boards Providing No Response** We identified two Boards that did not respond to our request for personnel data and financial information. The Division sent notices of noncompliance to the respective legislative committees as required by R.S. 49:1301. One of the Boards also failed to respond to our request in the prior year. The Legislature may wish to consider taking action against Boards that fail to comply with the reporting requirements in state law.
- **Inactive Boards** We identified 14 inactive Boards that do not appear to be fulfilling their established functions. 10 of these inactive Boards were also identified as inactive in the prior year. We recommend that the Legislature consider abolishing these Boards or taking other actions (additional legislation, appropriations, or board appointments) to assist them in fulfilling their established function.
- **Board Activity** We identified 39 Boards that reported their status as active but have not reported any meeting notices or minutes subsequent

to December 31, 2019. Also, nine of these Boards have no board members identified on the website. We recommend that the Division continue to work with these Boards to ensure they are appropriately reporting their status and complying with the reporting requirements in state law to make their meeting notices and minutes available on the website.

• **Board Per Diem, Salaries, and Travel Expenses** - For fiscal year 2023, Boards budgeted approximately \$1.5 million for Board member per diems, \$2.5 million for Board member salaries, and \$2.3 million for Board member travel expenses.

Boards & Commissions Website

R.S. 49:1301 requires the Commissioner of Administration to establish and maintain a website containing information on Boards: <u>https://wwwcfprd.doa.louisiana.gov/boardsandcommissions/home.cfm.</u>

The accuracy of each Board's self-reported information available on this website is solely dependent upon the timeliness and accuracy of each Board's data entry. As a result, anyone attempting to access information about current budgets or expenses for a specific Board may instead retrieve information that is outdated or inaccurate.

We recommend that the Division continue to work with our office regarding the identification of Boards to be added or removed from the database and the form and content of the database fields. We are available to meet with the Division to discuss updates and/or improvements to the website database.

Number of Boards Reported

As of June 30, 2023, the website contains information on 483 Boards (see Appendix B), which is a net increase of five from the previous year. This net figure reflects the addition of 11 Boards and the removal of six Boards.

The 11 Boards added include seven new Boards created during the 2022 legislative sessions and four existing Boards not previously included in the database. Boards added to the database during the year ended June 30, 2023, are as follows: Baker Main Street Economic Development District; Board of Directors of the Special School District; Calcasieu Ship Channel Funding Management Board; Delta Agriculture Research and Sustainability District; Delta Bike Trail Commission; Dew Drop-America's Rock and Roll Museum Governing Board; Houma Restoration District; LaSalle Cultural Corridor District; Louis Armstrong Park Authority and Historic Jazz District; Louisiana Governor's Mansion Commission; and Plank Road Business Economic Development Board.

The six Boards removed include four that were abolished during the 2022 legislative sessions, one with enabling legislation only effective through March 31, 2021, and one with enabling legislation only effective through January 12, 2023. Boards removed from the database during the year ended June 30, 2023, are as follows: Calcasieu-Cameron Navigation District; Health Education Authority of Louisiana; Healthy Moms, Healthy Babies Advisory Council; Medical Education Commission; Streamlining Government Commission; and Tioga Heritage Park and Museum Governing Board.

The effects of the laws enacted during the 2023 Regular Legislative Session are not reflected in the database as of June 30, 2023. Any new or abolished Boards resulting from the 2023 Regular Legislative Session will be added or removed prior to the 2024 reporting period.

Boards Providing No Response

R.S. 24:513.2(F) directs all agencies, boards, commissions, and departments of the state and its political subdivisions to furnish information and reports as requested by the Legislative Auditor to fulfill his responsibilities. All Boards were requested to provide contact information, membership information, and statutory or legal authority relative to the entity.

R.S. 39:1335 and 1336 require licensing agencies to provide summary and detailed information pertaining to actual and budgeted revenues by source, expenditures by category, and fund balances; performance indicators; and certain general information pertaining to the Board and its authority and functions.

All other Boards were requested to provide similar information, except that the financial and budget information was requested in summary form only, and information pertaining to performance indicators was not requested.

As of June 30, 2023, the following two Boards did not respond to our request for personnel data and financial information. One of these Boards also failed to respond to our request in the prior year.

1. Bi-State Corridor Commission*

Purpose or function:	Provide an information forum on the construction, expansion, improvement, or extension of a route designated U.S. 371, including the four-lane improvements or any portion thereof within the boundaries of the district; the construction of bridges, overpasses, causeways, underpasses, traffic circles, interchanges, and landscaping relating thereto; and the long-term economic/industrial development and tourism development of the corridor area.

Date of last meeting:	No record of meetings posted in database.

2. El Camino East-West Corridor Commission

Purpose or function:	Secure funds for four-lanes of the El Camino Corridor.
Year created:	1992

Date of last meeting:	No record of meetings posted in database.

*Board also identified as nonresponsive in the prior year.

A joint letter from the Commissioner of Administration and the Legislative Auditor requesting information was mailed to all Boards identified in our report (Appendix B). Numerous requests to the Boards listed above were made by the Division's staff to submit the requested information in the database.

In accordance with R.S. 49:1301, the Division sent notices of noncompliance to each Board that failed to respond to its requests. In addition, notices of each Board's failure to respond were sent to the state departments of which the Board is a part, the Senate Committee on Senate and Governmental Affairs, the House Committee on House and Governmental Affairs, and the oversight committees for each Board. The Legislature may wish to consider taking action against Boards that fail to comply with the reporting requirements in state law.

Inactive Boards

The following 14 Boards were created by the Legislature prior to the 2022 Legislative Session and were inactive, not fully organized, or disbanded as of June 30, 2023, due to the reasons below, which were obtained from the Board's representative. Ten of these Boards were also inactive during the prior year. Because these Boards do not appear to be fulfilling their established functions, the Legislature should consider

abolishing them or taking other actions (additional legislation, appropriations, or board appointments) to assist them in fulfilling their established function.

1. Advisory Subcommittee of the Accountability Commission *

Purpose or function:	To report on and make recommendations regarding the overall effectiveness of the teacher evaluation system.

Reason for inactivity provided by Board representative:	The Commission serves in an advisory capacity only. HB 555 was filed in the 2021 Regular Legislative Session to repeal the statute relative to this subcommittee; however, no action was taken on the proposed legislation.

Purpose or function:	The Federal Highway Administration has changed its procedures. DOTD is the sole agency responsible for reviewing federal byway grants.

R.S. 49:1302 requires notices and minutes of board meetings to be included on the Boards & Commissions website. The Division has requested all Boards to either post their meeting notices and minutes directly to the Boards & Commissions website or provide a link to meeting notices and minutes that are posted on the Board's own website. Based on our review of the 462 Boards with a reported status of active, we identified 39 Boards as listed below that have not reported any meeting notices or minutes subsequent to December 31, 2019. Also, nine of these Boards have no board members identified on the website. We recommend the Division continue to work with these Boards to ensure all Boards are appropriately reporting their status and complying with the reporting requirements to make their meeting notices and minutes available on the Boards & Commissions website.

Boards have until May 1, 2024, to enter fiscal year 2024 budgets and fiscal year 2023 actual expenses in the database.
