Independent Auditors' Report

Opinion

We have audited the accompanying financial statements of the business-type activities of the Louisiana Rice Research Board (the Board), as of and for the year ended June 30, 2023, and the related notes to the financial statements, which collectively comprise the Board's basic financial statements as listed in the table of contents.

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the Board as of June 30, 2023, and the respective changes in its net position and its cash flows for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS) and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Board to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

Responsibilities of Management for the Financial Statements

The Division of Administration Office of Statewide Reporting and Accounting Policy's annual fiscal reporting packet, on pages 14 - 45, is presented for purposes of additional analysis and is not a required part of the basic financial statements.

The Division of Administration Office of Statewide Reporting and Accounting Policy's annual fiscal reporting packet is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the basic financial statements. Such information has been subjected to the auditing procedures applied in the audit of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements or to the basic financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the supplementary information is fairly stated, in all material respects, in relation to the basic financial statements as a whole.

Management's Discussion and Analysis

June 30, 2023

The management's discussion and analysis of the Louisiana Rice Research Board's (the Board) financial performance presents a narrative overview and analysis of the Board's financial activities for the year ended June 30, 2023. This document focuses on the current year's activities, resulting changes and currently known facts. Please read this document in conjunction with the Board's financial statements.

The Management's Discussion and Analysis (MD&A) for the Board is designed to:

- 1. Assist the reader in focusing on significant financial issues;
- 2. Identify changes in the Board's overall financial position and results of operations and assist the user in determining whether financial position has improved or deteriorated as a result of the year's operations;

As management of the Board, we offer the readers of the Board's financial statements this narrative overview and analysis of the financial activities of the Board as of and for the year ended June 30, 2023. We encourage readers to consider the information presented here in conjunction with the Board's basic financial statements and supplementary information provided in this report in assessing the efficiency and effectiveness of our stewardship of public resources.

The MD&A is an element of the reporting model adopted by the Governmental Accounting Standards Board (GASB) in their Statement No. 34 "*Basic Financial Statements and Management's Discussion and Analysis for State and Local Governments*" issued June 1999. Certain comparative information between the current year and the prior year is required to be presented in the MD&A.

Overview of the Basic Financial Statements

Financial Highlights

The Louisiana Rice Research Board's assets exceeded its liabilities at the close of fiscal year 2023 by \$2,580,063. The Board's assets increased by \$21,483 or 0.84%.

The Louisiana Rice Research Board's operating revenue decreased by \$4,810 or 0.28% compared to the prior year. Operating expenses decreased by \$357,751 or 17.61% primarily due to a decrease in research expenses.

Management's Discussion and Analysis

Required Financial Statements

The basic financial statements of the Board report information about the Board using Governmental Accounting Standards Board (GASB) accounting principles. These statements offer short-term and long-term financial information about its activities.

The statement of net position includes all of the Board's assets and liabilities. The difference between assets and liabilities is net position. It provides the basis for evaluating the capital structure of the Board and assessing the liquidity and financial flexibility of the Board.

All of the current year's revenues and expenses are accounted for in the statement of revenues, expenses and changes in net position. This statement measures improvements in the Board's operations over the past year. Regardless of when cash is affected, all changes in net position are reported when the underlying transactions occur. As a result, there are transactions included that will not affect cash until future fiscal periods.

The final required financial statement is the statement of cash flows. The primary purpose of this statement is to provide information about the Board's cash from operations, investing and financing activities, and to provide answers to such questions as where cash came from, what was cash used for and what was the change in cash balance during the reporting period.

Notes to Financial Statements

The notes provide additional information that is essential to a full understanding of the data provided in the financial statements. The notes to the financial statements can be found immediately following the fund financial statements.

(1) <u>Summary of Significant Accounting Policies</u>

(a) Introduction

The Louisiana Rice Research Board (the Board) is a component unit of the State of Louisiana created within the Louisiana Department of Agriculture and Forestry, as provided by Louisiana Revised Statutes 551.71-77. The Board is composed of thirteen members appointed by the governor, subject to Senate confirmation. All members of the Board are required to be rice producers. Six members are appointed from nominations submitted by the Louisiana Farm Bureau, Inc., five members are appointed from nominations submitted by the Louisiana Rice Growers Association, and two members are appointed from nominations submitted by the American Rice Growers Cooperative Association. The members serve terms of four years and are eligible for reappointment. The Board is charged with the responsibility to promote rice research. The commissioner of Agriculture & Forestry serves as an advisor to the Board.

(b) <u>Reporting Entity</u>

Section 2100 of the Governmental Accounting Standards Board (GASB) Codification of Governmental Accounting and Financial Reporting Standards established criteria for determining the governmental reporting entity and component units that should be included in the reporting entity. In conformance with GASB Codification Section 2100, this entity is a component unit of the State of Louisiana because the Board is not legally separate and the State holds the Board's corporate powers. The accompanying basic financial statements present only the transactions of the Louisiana Rice Research Board, a component unit of the State of Louisiana.

(c) **Basis of Accounting**

Basis of accounting refers to when revenues and expenses are recognized in the accounts and reported on the financial statements. The financial statements of the Board have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

(d) **Basis of Presentation**

Proprietary funds are used to account for the Board's ongoing operations and activities which are similar to those in the private sector. Proprietary funds are accounted for using a flow of economic resources measurement focus under which all assets and liabilities associated with these funds are included in the statement of net position and are prepared in conformity with accounting principles generally accepted in the United States of America (GAAP). Application of GAAP often requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and the reported revenues and expenses. Actual results could differ from those estimates. The GASB is the accepted standard-setting body for establishing governmental accounting and financial reporting principles.

(e) <u>Use of Estimates</u>

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

(f) <u>Cash and Cash Equivalents</u>

Cash includes amounts in demand deposits, interest-bearing demand deposits and time deposits. Cash equivalents include amounts in time deposits and those investments with original maturities of 90 days or less. Under state law, the Board may deposit funds in demand deposits, interest bearing deposits, money market accounts or time deposits with state banks organized under Louisiana law or under the laws of the United States.

In accordance with R.S. 33:2955, the Board as a political subdivision, is authorized to invest funds in direct U.S. Treasury obligations, bonds, debentures, notes or other evidence of indebtedness issued or guaranteed by the full faith and credit of the United States of America, direct security repurchase agreements, time certificate of deposits, mutual or equity trusts funds institutions, guaranteed investment contracts, investment grade commercial paper and bonds, debentures, notes or other indebtedness issued by a state of the United States or any such state's political subdivision that meet stated conditions.

(g) <u>Receivables</u>

Receivables consist of assessments due from the Louisiana Department of Agriculture and Forestry and are stated at net realizable value. Receivables are considered to be fully collectible; therefore, no allowance for doubtful accounts is required.

(h) <u>Net Position</u>

Net position is composed of the various net earnings from operations, non-operating revenues, expenses, and contributions of capital. Net position is classified in the following three components:

<u>Net investment in capital assets</u> - Consists of all capital assets, net of accumulated depreciation and reduced by outstanding balances of any bonds or other borrowing that are attributable to the acquisition, construction, or improvement of those assets.

<u>Restricted</u> - Consists of external constraints placed on net position used by creditors, grantors, contributors, or laws or regulations of the government or constraints imposed by law through constitutional provisions or enabling legislation.

<u>Unrestricted</u> - Consists of all other assets that are not included in the other categories previously mentioned.

The Board's policy is to first apply restricted resources when an expense is incurred for purposes for which both restricted and unrestricted net position is available.

(i) **Operating Revenues**

Operating revenues consist primarily of assessments received from the Department of Agriculture and Forestry as well as export fees.

(j) <u>Non-operating Revenues</u>

Non-operating revenues consist primarily of interest income.

(k) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Actual results could differ from those estimates.

(2) Cash and Cash Equivalents

At June 30, 2023, the carrying amount of the Board's bank deposits was \$2,244,986. These deposits are stated at cost which approximates market. The Board has no formal policy regarding custodial credit risk, however, under state law, these deposits (or the resulting bank balances) must be secured by federal deposit insurance, or the pledge of securities owned by the fiscal agent bank. The market value of the pledged securities plus the federal deposit insurance must at all times equal the amount on deposit with the fiscal agent.

Cash and deposits are categorized into three categories of credit risk. Category 1 includes deposits covered by federal depository insurance or by collateral held by the Board or its agent, in the Board's name. Category 2 includes deposits covered by collateral held by the pledging financial institution's trust department, or its agent in the Board's name. Category 3 includes deposits covered by collateral held by the pledging financial institution, or its trust department or agent but not in the Board's name, and deposits which are uninsured and uncollateralized.

Custodial credit risk is the risk that in the event of a failure of a depository financial institution, the Board's deposits may not be recovered. At June 30, 2023, the bank balance was \$3,163,357. Of the bank balance, \$500,000 was covered by federal depository insurance (Category 1). In compliance with State laws, the remaining balance of \$2,663,357 was secured by bank-owned securities specifically pledged to the Board and held by an independent custodian bank jointly in the name of the Board and the depository bank (Category 2).

(3) <u>Receivables</u>

At June 30, 2023, receivables totaled \$335,077. These are assessments due from the Department of Agriculture and Forestry which were subsequently collected.

(4) Contingent Liabilities

The Board is a defendant in litigation related to rice assessments that occurred from 2011 to 2014. In this case, the court has issued a summary judgment against the Board and the Louisiana Department of Agriculture and Forestry in the amount of \$5,005,154 plus judicial interest of \$2,489,411. Because the judgment does not specify the amounts or proportion due from each defendant, a reasonable estimate of the amount due from the Board could not be determined. Accordingly, the Board has not recorded a liability for this judgement at June 30, 2023.

(5) Subsequent Events

The Board has evaluated subsequent events for potential recognition of disclosure in the financial statements through September 13, 2023, the date which the financial statements were available to be issued.
