INDEPENDENT ACCOUNTANTS' EXAMINATION REPORT

We have examined the accompanying Summary of Cash Available for Settlements, the Schedule of the 2021 Tax Roll and Settlements to Taxing Bodies, and the Affidavit of the East Baton Rouge Parish Sheriff as Tax Collector (Sheriff) for the year ended June 30, 2022 (collectively the Annual Report of the Tax Collector). The Sheriff's management is responsible for the Annual Report of the Tax Collector, in accordance with the presentation format agreed upon by the consolidated government of East Baton Rouge Parish (City-Parish). Our responsibility is to express an opinion on the Annual Report of the Tax Collector based on our examination.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. Those standards require that we plan and perform the examination to obtain reasonable assurance about whether the Annual Report of the Tax Collector is fairly presented in accordance with the presentation format agreed upon by the City-Parish and the Sheriff, in all material respects. An examination involves performing procedures to obtain evidence about the Annual Report of the Tax Collector. The nature, timing and extent of the procedures selected depend on our judgment, including an assessment of the risks of material misstatement in the Annual Report of the Tax Collector, whether due to fraud or error. We believe that the evidence we obtained is sufficient and appropriate to provide a reasonable basis for our opinion.

We are required to be independent and to meet our other ethical responsibilities in accordance with relevant ethical requirements relating to the engagement.

In accordance with Louisiana R.S. 11:82, all sheriffs, or other officials responsible for tax collections, deduct amounts certified by the Louisiana Legislative Auditor, and remit those amounts to the appropriate retirement systems. A taxing district filed suit in the 19th Judicial District Court on November 7, 2022. The lawsuit asserts that the very statute requiring this transaction is unconstitutional or is being unconstitutionally applied as these deductions include amounts taken from dedicated taxes. If this taxing district prevails, it will significantly affect the current process of tax collections and settlements. Our opinion is not modified with respect to this matter.

In our opinion, the Summary of Cash Available for Settlements, the Schedule of the 2021 Tax Roll and Settlements to Taxing Bodies, and the Affidavit of the East Baton Rouge Parish Sheriff referred to above are fairly presented in accordance with the presentation format agreed upon by the City-Parish and the Sheriff, in all material respects.



These schedules are intended solely for the information and use of the East Baton Rouge Parish Sheriff and the consolidated government of East Baton Rouge Parish and are not intended to be and should not be used by anyone other than these respective parties.
