#### **Background**

The Lafitte Area Independent Levee District (LAILD or the District) was created on January 1, 2008. LAILD is domiciled in the Town of Jean Lafitte and provides flood protection through the construction and maintenance of levees and drainage for those areas within its boundaries – including Jean Lafitte and unincorporated areas of Lafitte, Barataria, and Crown Point – of Jefferson Parish.

LAILD's Board of Commissioners (Board) consists of five<sup>3</sup> members who reside in Jefferson Parish within the levee district.4 The five members, subject to confirmation by the Senate, are appointed by the Governor for four-year terms and include one member nominated by the governing authority of Jean Lafitte and four members nominated by the legislators representing the portion of Jefferson Parish located within the levee district. Members are appointed so that there are always at least two professionals with at least 10 years of experience in their respective disciplines on the Board, one of whom must be an engineer. Board members receive a per diem set by the federal government for attendance at each monthly board meeting, which is \$156 per meeting during fiscal year 2023.5

## Why We Compiled This Informational Brief

Because of legislative interest in the Lafitte Area Independent Levee District's (LAILD or the District) operations, we obtained and reviewed policies, contracts, financial statements, board meeting minutes, and contract payments.

Informational briefs are intended to provide more timely information than standards-based performance audits. While these informational briefs do not follow all *Governmental Auditing Standards*, we conduct quality assurance activities to ensure the information presented is accurate. We met with the District and incorporated its feedback throughout this informational brief.

State law<sup>6</sup> gives the Board the authority to buy and hold, sell and transfer, or exchange property; make and execute contracts; and perform all acts necessary to ensure the thorough and adequate protection of lands of the District from flood damage and for adequate drainage control. The Board is also statutorily required to

examine all of the accounts and operations of the Board and determine in what manner work shall be undertaken.

As of March 2023, LAILD has five employees, including a director of administration, a part-time assistant, and three equipment operators. In addition, LAILD contracts with one program manager and project managers from two engineering firms. Generally, LAILD is funded by Jefferson Parish and the Coastal Protection and Restoration Authority (CPRA) of Louisiana, as well as through property taxes, as discussed further in the following section.

#### **What We Found**

**During fiscal years 2018 through 2022, LAILD's revenues increased from \$1,593,389 to \$17,626,376.** This increase in revenue is largely due to reimbursements from Jefferson Parish and CPRA for expenses related to Hurricane Ida in August 2021. LAILD also receives funding from a dedicated property tax millage; however, in fiscal year 2022 the assessor reduced property values by 80% on levee properties heavily affected by Hurricane Ida. This reduction decreased LAILD's property tax revenue, which funds the District's operating expenses. Exhibit 1 summarizes LAILD's revenues during fiscal years 2018 through 2022.

During fiscal years 2018 through 2022, LAILD's expenditures increased from \$3,425,577 to \$20,030,944. This increase was largely due to an increase in hurricane and tropical storm expenditures, as well as capital outlay spending. Exhibit 2 summarizes LAILD's expenditures during fiscal years 2018 through 2022.

Specifically, during fiscal years 2018 through 2022, LAILD spent approximately \$28.5 million on capital outlay flood protection projects including levee construction and engineering, and drainage engineering. See Appendix A for a complete list of contracts and amounts paid from February 2015 through February 2023.

State law<sup>8</sup> requires that LAILD conduct all business in accordance with the provisions of the Louisiana Public Bid Law,<sup>9</sup> which sets forth dollar thresholds that require the solicitation of quotes or bids. According to LAILD policy, when those thresholds are met, the District follows the procedures required by the bid law and obtains the required quotes or bids, advertises when needed, holds open bid tabulation meetings as needed, etc. Contracts with related parties (family and business interests) are strictly prohibited by LAILD policy. If bids are

needed for construction activity, LAILD typically relies on a third-party consultant/engineer to prepare a bid package that includes the scope and specifications of the project. Although the Public Bid Law does not require professional services such as engineering to be bid, LAILD policy states that competitive proposals (i.e., RFPs) will be issued at the discretion of the Board when it determines that it would benefit the District.

As of February 2023, LAILD has 28 active contracts for levee construction/engineering or drainage engineering projects in various phases of design. Following Hurricane Katrina in 2005, the U.S. Army Corps of Engineers (Corps) decided to only let contracts for projects that would provide 100year flood protection. As a result, smaller levee districts such as LAILD were created so that the districts could continue to work on the list of lesser projects previously handled by the Corps. According to LAILD, the levee projects come from the Corps' preauthorized<sup>10</sup> annual flood control activity reports,<sup>11</sup> and the Board decides the priority of the projects based on available funding. After LAILD was created in 2008, the District continued to lobby the state and federal government for protection and secured funds through the Department of Transportation and Development's (DOTD) Statewide Flood Control Program and CPRA of Louisiana.<sup>12</sup> Exhibit 3 shows LAILD's 10 levee projects in bold followed by the 18 associated drainage projects as of February 2023. 13 See Appendix A for details related to each contract including the contractor, date signed, total amount of contract, and total spent as of February 2023.

As of February 2023, LAILD has 28 contracts with 13 firms for levee construction/engineering or drainage engineering projects, and two contracts for project managers that oversee the other 28 projects. The majority of the projects are related to drainage, with 18 drainage/pump station projects currently in the design phase. Appendix A contains a list of current LAILD contracts for levee construction, levee engineering, and drainage engineering projects that have been let since February 2015, as well as contract totals and amounts paid as of February 2023. Of the 28 current contracts, 27 are in the design phase of the project and therefore were let as professional services contracts<sup>14</sup> to engineering firms. These engineering firms are contracted by LAILD to conduct the bid process and select the firms to perform the construction phases of the projects. As of February 2023, LAILD has one project in the construction phase, as shown in Appendix A. Appendix B shows a map of the basins that comprise the Lafitte Tidal Protection System and LAILD's current levee engineering projects.
