We have audited the accompanying statements of financial position of Consolidated Gravity Drainage District No. 1 as of December 31, 1999 and 1998, and the related statements of activities and cash flows for the years then ended. These financial statements are the responsibility of the District's management. Our responsibility is to express an opinion on these financial statements based on our audit.

NOTE 1. - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Consolidated Gravity Drainage District No. 1 of Jefferson Davis Parish is a political subdivision of the State of Louisiana and also a component unit of the Jefferson Davis Parish Police Jury.

The entity provides maintenance for drainage laterals for approximately the north half of Jefferson Davis Parish, State of Louisiana.

A. FUND ACCOUNTING

The accounts of the Consolidated Gravity Drainage District No. 1 of Jefferson Davis Parish are organized on the basis of one fund, the general fund. The operation of the fund is accounted for with a separate set of self-balancing accounts that comprises its assets, liabilities, net assets, revenues, and expenditures of expenses. Revenues are accounted for in the individual fund based upon the purpose for which they are to be spent and the means by which spending activities are controlled. The fund presented in the financial statements are described as follows:

General Fund:

The General Fund is the general operating fund of the Consolidated Gravity Drainage District No. 1 of Jefferson Davis Parish. It is used to account for all financial resources except those required to be accounted for in other funds.

B. BASIS OF ACCOUNTING

Basis of accounting refers to when revenues and expenditures or expenses are recognized and reported in the financial statements. Basis of accounting relates to the timing of the measurements made, regardless of the measurement focus applied.

The governmental funds, are reported on the modified accrual basis of accounting utilizing the following practices in recording revenues and expenditures:

Revenues are recognized in the accounting period in which they become both measurable and available to finance expenditures of the fiscal period

Expenditures are measurable and should be recorded when the related liability is incurred.

C. BUDGETARY PRACTICES

The Consolidated Gravity Drainage District No. 1 of Jefferson Davis Parish utilized the following budgetary practices:

1. The Secretary-Treasurer prepares an operating budget and submits this budget to the board members for approval and adoption.

- 2. Meetings are held monthly and they are open to the public. The budget was adopted at a public meeting.
- 3. Budgets are adopted on a basis consistent with generally accepted accounting principles (GAAP).
- 4. All budgetary appropriations lapse at the end of each fiscal year.

D. USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of financial statements, and the reported amounts of revenues and expenses during the reported period. Actual results may differ from those estimates.

NOTE 2. - INVESTMENTS

Investments are stated at market value. These investments are invested in Hibernia U.S. Treasury Money Fund.

NOTE 3. - VACATION AND SICK LEAVE

The Consolidated Gravity Drainage District No. 1 of Jefferson Davis Parish does not have any employees therefore there is no formal leave policy.

NOTE 4. - EXPENDITURES

Actual and budget expenditures are favorable.

NOTE 5. - RECEIVABLES

NOTE 6. - PENSION PLAN

The Commissioners of the Consolidated Gravity Drainage District No. 1 of Jefferson Davis Parish do not participate in the Federal Retirement System. Consolidated Gravity Drainage District No. 1 does contribute to the District Attorney's Retirement System. Consolidated Gravity Drainage District No. 1 contributed \$2,295 and \$2,260 for the years ended December 31, 1999 and 1998, respectively.

NOTE 10. -- FINANCIAL INSTRUMENTS

Consolidated Gravity Drainage District No. 1 maintains its cash balances at one financial institution. The balances are insured by the FDIC up to \$100,000. The company maintains its investments with Hibernia Investment Securities, Inc. The balances are insured by Pershing Co. up to \$150 million. At December 31, 1999 and 1998 there were no uninsured balances at the institutions.

Report on Compliance and on Internal Control over Financial Reporting Based on an Audit of financial Statements Performed in Accordance with Governmental Auditing Standards

To the Board of Director's Consolidated Gravity Drainage District No. 1 Of Jefferson Davis Parish Jennings, Louisiana

We have audited the accompanying financial statements of Consolidated Gravity Drainage District No. 1 as of and for the years ended December 31, 1999 and 1998, and have issued our report thereon dated June 13, 2000. We conducted our audit in accordance with generally accepted auditing standards and the standards applicable to financial audits contained in <u>Government Auditing Standards</u>, issued by the comptroller General of the United States.

Compliance

As part of obtaining reasonable assurance about whether Consolidated Gravity Drainage District No. 1's financial statements are free of material misstatement, we performed tests of its compliance with certain provisions of laws, regulations, contracts and grants, with which noncompliance could have a direct and material effect on the determination of financial statement amounts. However, providing an opinion on compliance with those provisions was not an objective of our audit and, accordingly, we do not express such an opinion. The results of my tests disclosed no instances of noncompliance that are required to be reported under Government Auditing Standards.

Internal Control Over Financial Reporting

In planning and performing our audit, we considered Consolidated Gravity Drainage District No. 1's internal control over financial reporting in order to determine our auditing procedures for the purpose of expressing our opinion on the financial statements and not to provide assurance on the internal control over financial reporting. Our consideration of the internal control over financial reporting would not necessarily disclose all matters in the internal control over financial reporting that might be material weaknesses. A material weakness is a condition in which the design or operation of one or more of the internal control components does not reduce to a relatively low level the risk that misstatements in amounts that would be material in relation to the financial statements being audited may occur and not be detected within a timely period by employees in the normal course of performing their assigned functions. We noted no matters involving the internal control over financial reporting and its operation that we consider to be material weaknesses.

This report is intended for the information of the audit committee, management, and federal awarding agencies and pass-through entities. However, this report is a matter of public record and its distribution is not limited.
