NOTE 1-RECORDING OF TRANSACTIONS

Records provided to our office consisted of bank statements, check stubs, remittance advices, partial payroll records, and some invoices. None of these documents were in the form of finalized accounting records from which financial statements could be extracted.

In order to fulfill the requirements of the engagement by producing a summary of cash receipts and cash disbursements, we confirmed receipts by mail with the surrounding municipalities, governmental units, and other parties. With information obtained above, we were able to classify the deposits reflected in the Coroner's operating bank account and create a general ledger from which the schedule of cash receipts and cash disbursements was generated. Transactions, including those discussed in Note 4B, 4E, and 4F are not reflected in the schedule of cash receipts and cash disbursements. Disbursements were recorded from check stubs, bank statements and canceled checks with classification determined by payee and/or description on check stub.

In order to fulfill the requirements of the engagement concerning the schedule of accounts payable, we accumulated a list of probable vendors from the schedule of accounts payable provided by the coroner and a review of prior expenditure activities. We corresponded with the vendors to determine amounts due as well as services or products provided.

NOTE 2-DESCRIPTION OF CASH RECEIPTS

Annual allotment- This is the annual allotment provided by the Iberville Parish Council paid in monthly installments of \$10,000.

Start up costs- This amount represents a payment made to the Coroner's office by the Iberville Parish Council for \$53,265 to be used for the purchase of equipment and supplies. See Appendix A for a detailed list.

Computer equipment- The amount of \$4,150 was an allotment for computer equipment paid by the Iberville Parish Council.

Morgue supplies- The amount of \$3,450 was an allotment for morgue supplies paid by the Iberville Parish Council.

Service parish prisoners- This amount represents funds paid by the Iberville Parish Council to service parish prisoners.

Charge for services- other governmental units- This amount represents fees charged and received by the Coroner's Office for services to local municipalities and other governmental agencies.

NOTE 2 - DESCRIPTION OF CASH RECEIPTS (CONTINUED)

Charges for services- funeral homes, attorneys- This amount represents fees collected for services rendered to attorneys and funeral homes.

Unidentified receipts- This amount represents deposits for which the source was not determinable. See note 4-F.

NOTE 3-DESCRIPTION OF DISBURSEMENTS

Salaries- Monthly payroll and the required quarterly and annual reports were prepared by Paychex. This classification does not include payments to Dr. Joseph A. Freeman.

Suspense- This account represents disbursements that we were not able to classify by payee or by description.

ATM Debits- These are unidentified charges to the Coroner's bank account.

Other disbursements- All other disbursements were categorized based primarily on check stubs, payees, or descriptions. The records were not in a form so that invoices and other supporting documentation could be comprehensively utilized.

NOTE 4-OTHER FINDINGS

A. Accounting Records

The schedules incorporated in this report were generated from an incomplete and unorganized set of documents. In some instances, deposit slips lacked source information and expenditures lacked description and invoice support. These factors made it difficult to accurately classify receipts and disbursements.

B. Unrecorded Deposit

On April 16, 1997, the Iberville Parish Council issued a check for \$5,000 to the Coroner's office for start up costs. This deposit was not identified in the Coroner's office operating account located in the Bank of West Baton Rouge. As a result of a May 10, 2000 subpoena, evidence was presented that verified the \$5,000 was deposited into a personal account in the name of Joseph A. Freeman, M. D. and Dayne' Maria Freeman. Dr. Freeman's attorney, Eulis Simien, Jr., states that these funds were considered compensation for Dr. Freeman and were appropriately reported on the IRS form 1099. We have received no verification of this inclusion in the form 1099.

C. Capital Outlay Purchases

On August 29, 1997, Iberville Parish Council issued a check to the Coroner's office for start up costs in the amount of \$53,265. As evidenced by Appendix A, the start up costs included various capital outlay items such as a vehicle, office equipment, and office furniture. No evidence was found of the purchase of capital items (vehicle, office equipment, office furniture, etc.). Our examination revealed lease payments made to Copelco Capital for a copier and bin sorter. Also, it should be noted that in September and October 1999, two payments were made to the Ford Motor Credit Corporation for a total of \$1,128.

The computer allotment of \$4,150 provided by the Iberville Parish Council was utilized in the acquisition of a computer at a cost of \$4,192.

D. ATM Debits

Beginning in August of 1998, ATM debits were charged to the Coroner's operating account. The amount of the debits varied and no descriptions of the charges were provided. These ATM debits totaled \$1,804 for 1998 and \$1,300 for 1999.

E. Cash Received

The Iberville Parish Council issued monthly allotment payments to the Coroner's office in the amount of \$10,000. Four instances were noted in which the net amount of the deposit was less than the monthly allotment. These four instances of withdrawal totaled \$1,230.

F. Unidentified Receipts

Through third party confirmations, information was received concerning payments made to the Coroner's office. Many of these receipts were for smaller amounts and considered to have been a component of unidentified receipts as shown on the Schedule of Cash Receipts and Cash Disbursements. One receipt however, was too large to have been a component of unidentified receipts. This check was issued to the Coroner's office on October 31, 1999 by the Town of St. Gabriel in the amount of \$3,076 and is not accounted for in the Schedule of Cash Receipts and Cash Disbursements.

G. Payments made to Dr. Joseph A. Freeman, M. D.
