are members of the Social Security System. The Employee contribution was 7.65% of gross salary from July 1, 1995, through June 30, 1996. The District contributed an additional 7.65% of gross salary from July 1, 1995, through June 30, 1996. The District does not guarantee the benefits granted by the Social Security System.

PAROCHIAL EMPLOYEES' RETIREMENT SYSTEM

Employees of the Lafourche-Terrebonne Soil and Water Conservation District are members of the Parochial Employee's Retirement System of Louisiana ("system"), a cost-sharing, multiple employer public employees retirement system (PERS), controlled and administered by a separate board of trustees. The System is composed of two distinct plans, Plan A and Plan B, with separately held assets, and separate benefit provisions. Eligible employees of the Lafourche-Terrebonne Soil and Water Conservation District are members of Plan B. In the fiscal year ended June 30, 1996, the total payroll for employees of the Lafourche-Terrebonne Soil and Water Conservation District covered by the system under Plan B was \$26,579.55; the total payroll for all employees of the Lafourche-Terrebonne Soil and Water Conservation District was \$37,668.55.

2. CHANGES IN GENERAL FIXED ASSETS

The General Fixed Assets of the Lafourche-Terrebonne Soil and Water Conservation District remained unchanged for the year ended June 30, 1996.

Rents and royalties are recorded in the year earned.

Subsequently all other revenues are recorded when received.

(2) Expenditures

Expenditures were recognized in the accounting period in which the liabilities are both measurable and incurred.

D. BUDGETARY PRACTICES

A budget was submitted to the Office of Soil and Water Conservation, Louisiana Department of Agriculture and Forestry. State funding for the year was based upon the allocation procedures established in the program rules and regulations.

E. ANNUAL AND SICK LEAVE

Employees earn and accumulate annual and sick leave at various rates depending on their years of service. Unused annual and sick leave accumulates without limit. The number of hours of unused annual leave for which an employee may receive a lump sum payment upon termination from District employment may not exceed 300 hours.

At June 30, 1988 (fiscal close), the Laf.-Terrebonne Soil and Water Conservation District had accumulated and vested \$455.79 in leave privileges, required to be accrued under SFAS 403. Current year expenditures for salary and leave privileges total \$25,744.05.

F. PENSION PLAN

are presented as if the accounts were organized on the basis of funds and account groups, each of which would be considered a separate accounting entity. Since the District has financial resources which are required to be accounted for in other funds, a general fund and a special revenue fund were both employed.

B. FIXED ASSETS

Fixed assets used in the governmental fund type operations are accounted for in the General Fixed Assets account group, rather than the Governmental Fund. No depreciation has been provided on general fixed assets. All fixed assets are valued at historical cost.

This account group is not a "fund." It is concerned with the measurement of financial position, not with measurement of operations.

C. BASIS OF ACCOUNTING

Basis of accounting refers to when revenues and expenditures are recognized and reported in the financial statements. Basis of accounting relates to the timing of the measurements made, regardless of the measurement focus applied. The records are maintained on a cash basis and the accompanying financial statements have been converted to a modified accrual basis of accounting using the following practices:

(1) Revenue

State Funds are recorded when the District is entitled to the funds.

Newsletter sponsors and equipment rental are recorded in the year earned.

Interest income on time deposits is recorded when the deposits have matured and the income is available.

NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED JUNE 30, 1995

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Laf.-Terrebonne Soil and Water Conservation District was created by the Louisiana Legislature. The District primarily assists farmers and other land users in the wise use of their lands and the prevention of erosion of farm and urban land and the pollution of waters in the state. The governing board of supervisors administers the operations and responsibilities of the District in accordance with Louisiana Statutes. The board is comprised of five members.

In April 1984, the Financial Accounting Foundation established the Governmental Accounting Standards Board (GASB) to promulgate generally accepted accounting principles and reporting standards with respect to activities and transactions of state and local governmental entities. In November, 1984, the GASB issued a codification of governmental accounting and financial reporting standards. This codification and subsequent pronouncements are recognized as generally accepted accounting principles for state and local governments.

The financial statements of the Laf.-Terrebonne Soil and Water Conservation District are prepared in accordance with the standards established by the GASB. GASB Codification Section 2100 established criteria for determining the governmental reporting entity to be the Laf.-Terrebonne Soil and Water Conservation District. The accompanying statements present information only as to the transactions of the District.
