Background and Methodology

The result of our inversignee is the finding and recommendation hereix.

Finding and Recommendation

EMPLOYEE RECEIVED PAYMENTS FROM VENDORS

During October 15%, Mr. Todd F. Naquin, systems analyst manager, received \$1,000 from Network Driven Communications, Inc., (Netdrive) and during December 1995, he received \$1,000 from CAE Committing, Inc., (CAE), Burth Netdrive and CAE were vestors of Thibofust Retireland Medical Concerc theoritab.

From Jans 6, 1996, to September 20, 1996, the hospital purchased computer parts and services training 552,098 from Neutrice. The hospital's purchase requisitions were signed by Mr. Napain, On October 9, 1996, Neutrice, issued a check the \$1,000 payable to Mr. Napain, Neutrinos on the check informat hat it was accusted for Mr. Napain on October 14, 1998.

When questioned about this payment, Mr. Naquin informed us that he did not recall receiving any memory from Nutation and would have to shock his seconds. Though requests have been made of Mr. Naquin and his attentive, no further explanation as to the purpose of this payment has been received.

Mr. John Proset, an owner of Natátric, informed us that Natátric provided services to I-Way Networks, Inc. According to Mr. Preast, Natátrio's payment to Mr. Nação was roland to thin work. Mr. John Pather and Mr. Mark Yoang, events of I-Way, stated that Mr. Nação sever perferented are worked I-Way while a su information or an ensemption of Studios.

Mr. Nuquia informed us that he remembers receiving the \$1,000 from C&E but is not certain velocitie it was for "UND?" work or for "pulling order." Mr. Naquin stated that the proment was not for work done at the barghtal but may have been work performed for Mr. Peeut or the Lonisiante Department of Agriculture (the former unableser of Mr. Peeut).

Mr. Evenett stated that he did nor nearll why CdEI paid Mr. Naquin the \$1,000 in December 1996, and added that it must have been for basiness referred to CdEI. A CdEI invoice log parvialed by Nr. Eventt indicates that, during the period October 1990 through May 1997, CdEE conducting to because ather base with the human law the *L*-invision Theoretimes of *L*-invision.

These actives indicate that Mr. Naquin may have violated one or more of the following previsions of Louisians law:

- R.S. 16161 pervides that prehibided splitting of profix, fees, or somalisations in the giving, affining to give, receiving or offering to review, denety or indirately, anything of apperture present or prespective value by or to a public offering of public employee, when such value is desired from any appearement or contrast to value by more any availabilities thereoff to a sarry.
- R.S. 42.3113/CK20 provides that no public services shall sociate asphing, of economic value for or in consideration of services endered fants any pervise for vibous such public asverse would be prohibited from economics, a gift. R.S. 42:3115 padabits public services for receiving a gift from anyone who has a bacterin midlarebit with the samero.

We recentrent that the hospital ensure compliance with the polisies and procedures that probin employees from accepting morey, glfs, or neyhing of value from any individual se compariso conducting or attempting to conduct balances with the hospital. Also, we reconstruct that the Distric Answey for the Sweatenth Judicial District of Louisans and the Louisans Band of Diffusion with this distribution and taka accentions action.
