Note 1 - Summary of Significant Accounting Policies

The Terrebonne Economic Development District (the District) was created on June 1, 1989, under House Bill No. 115 of 1989, of the State of Louisiana, for the purpose of promoting, encouraging and participating in industrial development to stimulate the economy through commerce, industry and research, and for the utilization and development of natural physical and human resources of the area by providing job opportunities within the boundaries of Terrebonne Parish.

The accounting and reporting policies of the District conforms to generally accepted accounting principles as applicable to governments. The following is a summary of the more significant accounting policies:

Reporting Units

The District has reviewed all of its activities and determined that there are no potential component units which should be included in the financial statements.

Fund Accounting

The government uses funds and account groups to report on its financial position and the results of its operations. Fund accounting is designed to demonstrate legal compliance and to aid financial management by segregating transactions related to certain government functions or activities.

A fund is a separate accounting entity with a self-balancing set of accounts. An account group, on the other hand, is a financial reporting device designated to provide accountability for certain assets and liabilities that are not recorded in the fund because they do not directly affect net expendable available financial resources.

Governmental Funds - Governmental Funds are those through which the governmental functions of the District are financed. The acquisition, use and balances of the District's expendable financial resources and the related liabilities are accounted for through Governmental Funds. The measurement focus is upon determination of changes in financial

positions, rather than upon net income determination. The following is the Governmental Fund of the District:

General Fund - The General Fund is the general operating fund of the District. It is used to account for all financial resources, except those that are required to be accounted for in another fund.

Basis of Accounting

Basis of accounting refers to when revenues and expenditures are recognized in the accounts and reported in the financial statements. Basis of accounting related to the timing of the measurements made, regardless of the measurement focus applied.

All governmental funds are accounted for using the modified accrual basis of accounting. Their revenues are recognized when they become measurable and available as net-current assets. All major revenues are susceptible to accrual.

Expenditures are generally recognized under the modified accrual basis of accounting, when the related fund liability is incurred. An exception to the general rule is principal and interest on general long-term debt which is recognized when due.

Operating Budgetary Data

The District has adopted the following procedures in establishing budgetary data:

1. No later than sixty (60) days prior to the first day of the fiscal year, the President shall submit to the Board a proposed operating budget for the upcoming fiscal year for review.
2. The Board shall hold a public hearing to receive public comments on the proposed budget prior to its adoption.
3. Public notice of the hearing shall be in the official journal, at least fifteen (15) days prior, and shall state the date, time, place and purpose of the hearing.

4. The budget shall be adopted at a regularly scheduled meeting.
5. Budgets are to be adopted on a basis materially consistent with generally accepted accounting principles.
6. All budgeted amounts which are not expended, or obligated through contracts, lapse at year end.

General Fixed Assets

The District has no fixed assets at July 1, 1996 and did not acquire any thru June 30, 1997.

Accumulated Vacation and Sick Leave

The District has no employees. There is no accumulated unpaid vacation and sick leave at June 30, 1997.

Encumbrances

Encumbrance accounting, under which purchase orders, contracts and other commitments are recorded in the fund general ledgers, is not utilized by the District.

Note 2 - Cash and Investments

Louisiana state laws allows all political subdivisions to invest excess funds in obligations of the United States, certificates of deposit of state and national banks having their principal office in Louisiana or any other Federally insured investment.

Note 2 - Cash and Investments - (continued)

State law requires that deposits of all political subdivisions be fully collateralized at all times. Acceptable collateralization includes the FDIC insurance and the market value of securities purchased and pledged to the political subdivisions. Obligations of the United States, and the State of Louisiana and certain political subdivisions are allowed as security for deposits. Obligations furnished as security must be held by the political subdivision or with an unaffiliated bank or trust company for the account of the political subdivisions.

The District's cash was not in excess of the FDIC insurance.

Note 3 - Compensation of Commission Members

No compensation was paid to Commission Members for the twelve month period ended June 30, 1997.

Note 4 - In-Kind Contributions

The District received various in-kind contributions during the twelve month period ended June 30, 1997. The following were furnished at no cost to the District: 1) office space, and 2) others.

While these contributions have not been reported, the offsetting expenditures have also not been reported.

Note 5 - Economic Dependency

The District is currently dependent on the non-monetary voluntary contribution of its Commission Members and the monetary contributions of the general public. If the amount of monetary contributions were reduced significantly from its current level, it could have an adverse impact on its current level of operations.
