We were engaged to apply certain investigative procedures to the financial records of Louisiana Horsemen's bookkeeper accounts at Delta Downs Race Track.

The procedures performed by us involved a review of canceled checks for Delta Downs Quarterhorse and Mixed Meets for race meets ending in 1996, 1997, and 1998. More specifically, we applied the following procedures as regarding the canceled checks provided:

- Identified the payee on the front of each check.
- Compared the named payee to the endorsed signature on the back of the check.
- Reviewed each check for evidence of Ms. Penny Barlow's bank account number at Cameron State Bank and/or endorsement of a check through the use of her signature stamp that she uses to sign each check as payor.
- Compared endorsement signatures to other checks with the same named payee for consistency of the signatures. Noted those checks whose endorsement signatures were not consistent and resembled the endorsement of Check 6278 that was confirmed deposited into Ms. Penny Barlow's bank account at Cameron State Bank, and those endorsements on checks made payable to Logan H. Cormier, who is Ms. Penny Barlow's son, as represented to us by your management, that included Ms. Penny Barlow's account number with Cameron State Bank.
- For those checks whose endorsement signatures resembled the endorsement on Check 6278, mentioned above, we obtained a copy of that payee's license application filed with the Louisiana State Racing Commission for comparison of signatures.

The scope of our investigation was limited, at your request, to the canceled checks issued by the Delta Downs bookkeeper, Ms. Penny Barlow. These checks were identified and provided by you and maintained at the Louisiana Horsemen's Benevolent & Protective Association, 1993, Inc. office located in New Orleans, Louisiana.

The following findings are a result of our procedures: the referenced checks are on file in your office, as our files only include copies.

1. The following checks include either or both an endorsement by Ms. Penny Barlow, by use of her signature stamp, or her account number at Cameron State Bank:
