A. FUND ACCOUNTING

are presented as if the accounts were organized on the basis of funds and account groups, each of which would be considered a segurate accounting entity. Since the Debtlict has no financial resources, which are required to be accounted for in other funds, only a general operating fund was used.

B. FOED ASSETS

Fined issues used in the governmental fund type operations are accounted for in the General Flood Assets account group, rather than the Governmental Fund. No depreciation has been provided on general fixed assets. All fixed assets are valued at Matricial cost.
