#### Summary Schedule of Current Year Findings

There is one finding for current year ended December 31, 2020.

#### 2020-001 Finding - Late Submission of Audit

Finding: The compilation report for the year ended December 31, 2020, was not submitted timely in accordance with the state law

Criteria: State law requires reports to be submitted no later than six months after Geaux 4 Kids's year end.

Cause: Geaux 4 Kids's was not aware of the reporting requirement to the State.

Effect: Geaux 4 Kids's compilation report was not submitted timely in accordance with state law.

Recommendation: We recommend that Geaux 4 Kids's established appropriate controls for ensuring the required reports will be submitted timely in the future.

Views of Responsible Officials and Planned Corrective Actions: Geaux 4 Kids has hired a new contract accountant to ensure accounting records are maintained on a timely basis. Geaux 4 Kids will implement procedures for ensuring the compilation report is submitted timely in the future.
