- Criteria or Specific Under Louisiana Statute 24:513, Hideaway Requirement: Road Sewerage District is required to submit a compilation of its annual financial statements to the Louisiana Legislative Auditor within six months of its year-end, December 31, 2021.
- Type of Finding: Noncompliance

Condition: The compilation was not submitted by June 30, 2022.

Effect: Noncompliance with state law regarding financial reporting.

Cause: The District needed additional time to gather all documents necessary for reporting on new investment accounts.

Recommendation: Hideaway Road Sewerage District should keep all accounting records up to date throughout the year.

Response: Management agrees with the finding.
