Accountant's Compilation Report

To the Board of Commissioners Broadmoor Crime Prevention and Improvement District Baton Rouge, Louisiana

Management has omitted certain required supplementary information, such as management's discussion and analysis and budgetary comparison information that the Governmental Accounting Standards Board requires to be presented to supplement the basic financial statements.
