

AFFIDAVIT

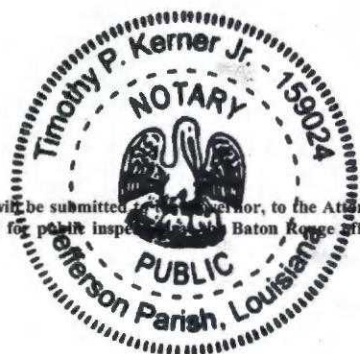
