

## AFFIDAVIT

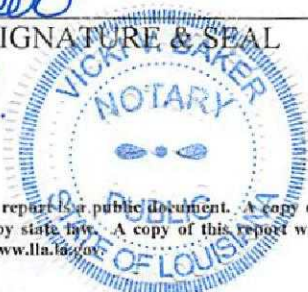
