Accountant's Compilation Report

Management is responsible for the accompanying financial statements of the governmental activities and the general fund of the 20th Judicial District Court Probation Office as of and for the year ended December 31, 2025, which collectively comprise the Probation Office's basic financial statements as listed in the table of contents in accordance with accounting principles generally accepted in the United States of America. We have performed a compilation engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the American Institute of Certified Public Accountants. We did not audit or review the financial statements nor were we required to perform any procedures to verify accuracy or completeness of the information provided by management. Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on these financial statements.

As permitted by the Louisiana Legislative Auditor (for compilation engagements), the financial statements have been prepared in accordance with the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.

Management has elected to omit substantially all of the disclosures required by accounting principles generally accepted in the United States of America. If the omitted disclosures were included in the financial statements, they might influence the user's conclusions about the 20th Judicial District Court Probation Office's financial position and the changes in net assets. Accordingly, these financial statements are not designed for those who are not informed about such matters.

Required Supplementary Information

Although not a part of financial statements, management's discussion and analysis presented of pages 3 and 4, and the budgetary comparison information presented on page 10, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational,

economic and historical context.

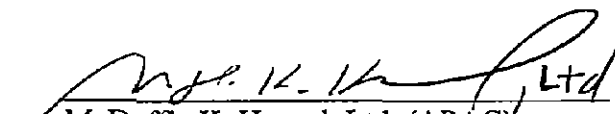
