## AFFIDAVIT

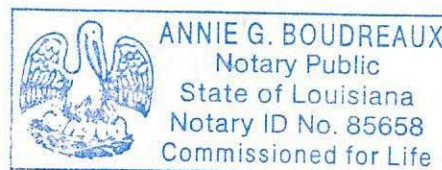
