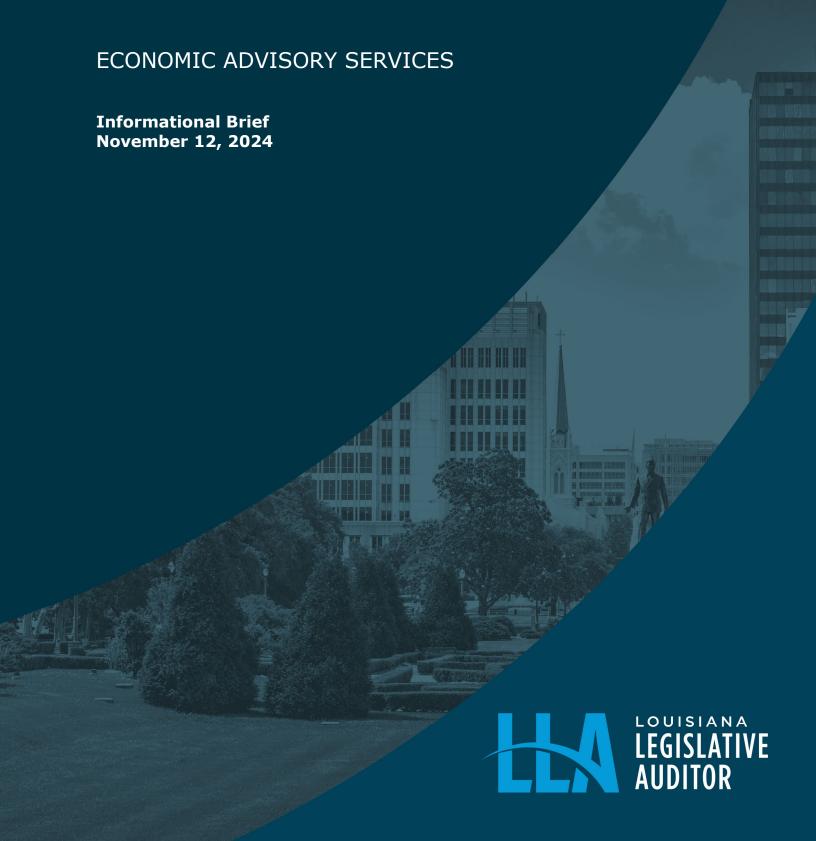

Cash Balances in Dedicated Funds

Fiscal Years 2020 through 2024

Background

This informational brief provides information on the accounting system cash balances in the state's constitutionally- and statutorily-dedicated funds. This report updates the information contained in our February 2016 informational report on Constitutional and Statutory Dedications. The purpose of this report is to provide information on the amount of cash carried over from each fiscal year to the next in the state's accounting system.

What We Found

We found that the year-end system cash balances in the state's dedicated funds rose from \$7.9 billion at the close of fiscal year (FY) 2020 to \$16.3 billion at the close of FY 2024, a 106% increase. This excludes the State General Fund Direct, as well as federal funds, self-

generated, and interagency transfers in the state general fund. The five funds that grew the most are all partly or fully dedicated to infrastructure, while the five funds that shrank the most are dedicated to health care, infrastructure, wildlife and fisheries, and education. Exhibit 1 shows the five funds that grew the most, the five funds that shrank the most, and the overall change in fund balances for the past five years.

Why We Compiled This Informational Brief

Because of legislative interest in the state's dedicated funds, we obtained information on the year-end system cash balances in each of the state's dedicated funds.

Informational briefs are intended to provide more timely information than standards-based performance audits. While these informational briefs do not follow all *Governmental Auditing Standards*, we conduct quality assurance activities to ensure the information presented is accurate.

Year-end accounting system cash balances (system cash balances) reflect the amount of cash in each fund at the end of the 45-day accrual period after the close of each fiscal year per the state's accounting system.¹ These represent the amounts carried forward into the next fiscal year. System cash balances may differ from the amount of cash reported in the Annual Comprehensive Financial Report (ACFR) or other reports that report balances as of June 30 because the system cash balances reflect transactions that occur after June 30 that are attributable to the previous fiscal year. For example, some agencies might receive cash from tax collections during July and August that is actually attributable to the previous fiscal year. In this scenario, the revenue received during the accrual period would be reported as a receivable as of June 30.

System cash balances also differ from fund balance, an accounting concept that describes the net position of governmental funds accounted for using the modified accrual basis of accounting, consistent with Generally Accepted Accounting Principles (GAAP). The fund balances reported in the state's ACFR reflect additional

adjustments made by the Office of Statewide Reporting and Accounting Policy to ensure that the figures comport with GAAP. For example, although the Water Sector Fund's cash balance for the end of FY 2023 was \$797 million, its GAAP fund balance was only \$50 million because it contained \$747 million in unearned revenues, which are recognized as a liability and subtracted in the calculation of fund balance. The numbers in this report are unaudited. Although audited figures are available for FYs 2020 through 2023, unaudited year-end system cash balances are presented in this report to give an equivalent comparison to the FY 2024 figures. Exhibit 2 contains the system cash balances in the state's dedicated funds, along with the year each fund was established.
