## AFFIDAVIT

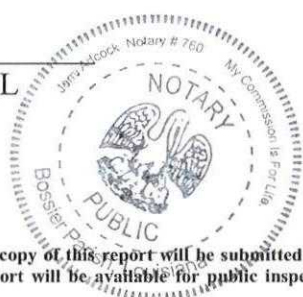
